### GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT NO. 68


The Board of Directors of Galveston County Municipal Utility District No. 68 will hold a regular meeting on Tuesday, June 17, 2025, at 2:00 p.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Blanco Room, Houston, Texas\*, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Discuss Association of Water Board Directors summer conference, approve reimbursement of eligible expenses, and authorize attendance at winter conference.
4. Financial and bookkeeping matters, including payment of the bills, review of investments, and amendment of budget, if necessary.
5. Tax assessment and collections matters, including delinquent tax collections, installment agreements, requests for estimates of taxable value, and payment of tax bills.
6. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
7. Plan of financing for 2025.
8. Detention pond and outfall channel facilities report, including review proposals and authorize appropriate action.
9. MS4 storm water management program report, including educational materials and public comments.
10. Engineering matters, approve pay estimates and change orders, including:
  - a. authorize design of facilities;
  - b. approve plans and specifications and authorize advertisement for bids for District facilities;
  - c. review bids and award contract for construction in the service area, including updates on construction of facilities to serve development in the District, including:
    - i. Bayou Ridge Lift Station;
  - d. approve pay estimates, time extensions, change orders, and final acceptance, as appropriate for construction of District facilities, including:
    - i. Trails at Woodhaven Lakes Section 2 water, sewer, and drainage;
    - ii. Sunset Grove Section 5; and
    - iii. Bayou Ridge Clearing & Grubbing, Detention Excavation, Water, Sewer, Drainage, and Paving and Left Turn Lane;
