- 3. The general operating budget was discussed. Changes to line items as follows: 6324 Lab down to \$22,00, 6489 Overflow structure add \$60,000, and 6491 Fence add \$150,000.
- 4. Adjustments were made reflecting changes in all three budgets. See copies from bookkeeper.
- 5. The CIP for the JSTP budget is still being reviewed by the engineer and Board Director Corey Manahan. Any adjustments needed will be presented at the regular August monthly meeting.
- 6. These budgets will be adopted at the August meeting with any changes that the bookkeeper will make as the Board has requested.
