
### FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 206

The Board of Directors of Fort Bend County Municipal Utility District No. 206 will hold a regular meeting on **Tuesday, August 12, 2025, at 12:30 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, **on the 13<sup>th</sup> Floor, Suite 1350, Neches Room**, Houston, Texas, to discuss and, if appropriate, approve and act upon the following items:

1. Public comments.
2. Approve minutes of prior meeting(s).
3. Financial and bookkeeping matters, including:
  - a. payment of the bills and review of investments;
  - b. conduct annual review of Investment Policy and adopt Resolution Regarding Annual Review of Investment Policy; and
  - c. review, revise, and adopt Resolution Establishing the Authorized Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions.
4. Tax assessment and collection matters, including:
  - a. delinquent tax collections, payment of tax bills, and estimate of value, as appropriate; and
  - b. discuss 2025 tax rate, set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.
5. Operation of District facilities, including:
  - a. hearing on termination of water and sewer service to delinquent customers and authorize termination of service; and
  - b. amend Rate Order.
6. Storm water facilities maintenance and operations, including:
  - a. Focal Point Basin Maintenance;
  - b. Detention Pond/Drainage Swale Maintenance; and
  - c. proposals for additional maintenance work.
7. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
  - a. Phase II MS4 Storm Water Management Plan, including pet waste stations;
  - b. Interconnect Agreement with Fort Bend County Municipal Utility District No. 30;

- c. water plant maintenance, including water plant no. 1 tank repair; and
  - d. deeds and easements and related environmental assessment proposals, consents to encroachment and encroachment agreements, requests for service, or utility commitment letters.
- 8. Attorney's report including:
  - a. adopt Resolution Voting for Water District Nominee for the Election of the Board of Directors of the Fort Bend Central Appraisal District; and
  - b. report on legislative matters.
