FIRST COLONY LEVEE IMPROVEMENT DISTRICT OF FORT BEND COUNTY, TEXAS



5. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
6. Conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form.
7. MS4 Storm Water Management Plan implementation.
8. Update from Fort Bend County Commissioners Court, and update from City of Sugar Land or City of Missouri City.

 - c. lake bottom survey and investigation;
 - d. easements and deeds;
 - e. authorize design, approve plans and specifications, authorize advertisement, award contract, and approve pay estimates and change orders for construction and maintenance projects in the district, including:
 - i. Safety, Monitoring and Operational Upgrades at Outfall Structure; and
 - ii. Oyster Creek outfall closures design.
13. Discuss Federal Emergency Management Agency involvement with dissolution of Community Identification Number.
14. Fort Bend Levee Coalition meetings and updates, National Flood Insurance Program ("NFIP") legislation, flood management conferences, and approve all reimbursements to directors.
