 - b. review matters relating to walking trail, proposed park rules, and pending signage, and take appropriate action; and

4. Coles Crossing Stormwater Detention and Water Quality Improvement Project, including associated costs, federal grant, timeline for implementation, and related matters.
5. Community events.
6. Discuss schedule for future joint meetings.
