## NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors ("Board") of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

## The meeting will be held on Tuesday, October 28, 2025 at 12:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Public comments;
- 2. Review and approve the minutes of the Board of Directors meeting held on September 23, 2025;
- 3. Conduct a public hearing regarding the adoption of the District's 2025 tax rate;
- 4. Levy of the District's 2025 debt service and maintenance tax rates, and the adoption of an Order in connection therewith;
- 5. Approval and execution of an Amendment to the District's Fourth Amended and Restated District Information Form;
- 6. Authorize preparation and filing of initial Local Government Bond, Tax, and Project report pursuant to chapter 403, Texas Gov't Code, as amended by H.B. 103;
- 7. Bookkeeper's Report, including financial and investment reports, discussion regarding status of investment of District funds, authorizing the payment of invoices presented, and authorizing any other actions necessary or appropriate in connection therewith;
- 8. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting and authorize any action in connection therewith;
- 9. Review and approve audit for fiscal year ended June 30, 2025, and authorize execution of Annual Filing Affidavit;
- 10. Tax Assessor-Collector's Report, including status of delinquent tax accounts, and authorizing payment of invoices presented and moving of accounts to uncollectible roll;

- 11. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment payment agreements, the filing of proofs of claim, and termination of water service, if appropriate;
