Minutes of the Meeting of Board of Directors January 13, 2025

The Board of Directors (the "Board") of Waller County Municipal Utility District No. 35 (the "District") met in regular session, open to the public, on January 13, 2025, in accordance with the duly posted Notice of Public Meeting, and the roll was called of the duly constituted members of the Board, as follows:

Victoria A. Battistini, President Ryan C. Ward, Vice President Jaclyn Day, Secretary Daniel C. Feiler, Assistant Secretary Tiffani S. Walker, Assistant Secretary

all of whom were present with the exception of Director Ward and Director Day, thus constituting a quorum. Director Day entered later in the meeting, as noted herein.

Also present were: Blair Bozoarth and Nick Monaldi of Quiddity Engineering, LLC ("Quiddity"); Jennifer Abad of Municipal Accounts & Consulting, L.P. ("MA&C"); Dana Hollingsworth of Municipal District Services, LLC ("MDS"); Stephen Eustis of Robert W. Baird & Co., Inc. ("Baird"); Patty Rodriguez of BLICO, Inc., dba Bob Leared Interests ("BLICO"); Tiffany Wilkes of Kudela & Bernheimer ("K&W"); Dennis Yazdanpanah, resident of the District; and Christina Cole and Kris Eddlemon of Schwartz, Page & Harding, L.L.P. ("SPH").

The President called the meeting to order and declared it open for such business as might regularly come before the Board.

PUBLIC COMMENTS

There were no comments from members of the public.

MINUTES

The Board considered the minutes of its meeting held on December 9, 2024. After discussion, it was moved by Director Feiler, seconded by Director Walker, and unanimously carried, that said minutes be approved, as written.

TAX ASSESSOR-COLLECTOR REPORT

Ms. Rodriguez presented to and reviewed with the Board a written Tax Assessor-Collector Report ("TAC Report") for the period ended December 31, 2024, including the disbursements presented therein for payment from the District's tax account, a copy of which TAC Report is attached hereto as **Exhibit A**. After discussion, on motion made by Director Feiler, seconded by Director Walker and unanimously carried, the Board approved the TAC Report and authorized the

payments listed therein.

RESOLUTION CONCERNING EXEMPTIONS FROM TAXATION

Ms. Cole outlined for the Board the various tax exemptions available for the District, including the exemptions provided for by Article VIII, Section 1-b of the Texas Constitution, and Section 11.13 of the Tax Code, as amended. She advised that under said provisions, the District may provide for the exemption of up to 20% (but not less than \$5,000, if granted) of the market value of residential homestead improvements for the year 2025, and the District may also exempt residential homesteads of persons who are under a disability for purposes of payment of disability insurance benefits under the Federal Old Age, Survivors and Disability Insurance Act, or its successor, or persons sixty-five years of age or older from ad valorem taxes levied by the District during the calendar year 2025, and, if any such exemptions are granted, they must be for not less than \$3,000 of the market value of such homesteads. After further discussion of the matter, Director Feiler moved that the District (a) not grant the residential homestead exemption and (b) not grant an exemption for persons under a disability or sixty-five years of age or older from ad valorem taxes levied by the District during the calendar year 2025, and that the Resolution attached hereto as **Exhibit B** relative to same be approved and adopted by the Board and District. Director Walker seconded said motion, which unanimously carried.

RESOLUTION AUTHORIZING AN ADDITIONAL PENALTY ON DELINQUENT PERSONAL PROPERTY TAXES

The Board considered the adoption of a Resolution Authorizing an Additional Penalty on Delinquent Personal Property Taxes, a copy of which is attached hereto as **Exhibit C**. Ms. Cole advised that the Board is authorized pursuant to Section 33.11 of the Texas Tax Code, as amended, to impose, under certain conditions, 60 days after the date the taxes become delinquent, an additional penalty not to exceed twenty percent (20%) of the total taxes, penalty and interest due the District on personal property taxes that remain delinquent as of said 60th day, as more fully described in said Resolution. After discussion, it was moved by Director Feiler, seconded by Director Walker and unanimously carried, that the Resolution Authorizing an Additional Penalty on Delinquent Personal Property Taxes be adopted by the Board, and that Perdue, Brandon, Fielder, Collins & Mott, PLLC, the District's delinquent tax attorneys, be authorized to proceed with the collection of the District's 2024 delinquent personal property accounts following proper notice as provided in said Resolution, including the filing of lawsuits, as necessary.

SPECIAL PURPOSE DISTRICT PUBLIC INFORMATION DATABASE

Ms. Cole reminded the Board that, pursuant to provisions of Chapter 403, Texas Government Code, and Chapter 203, Texas Local Government Code, the District is required to submit information to the Texas Comptroller of Public Accounts (the "Comptroller") for inclusion in a Special Purpose District Public Information Database. Following discussion, Director Feiler moved, Director Battistini seconded, and it was unanimously carried, that the District's auditor, Forvis Mazars, LLP, be authorized to prepare the required information and submit same to the Comptroller for inclusion in the Special Purpose District Information Database.

Director Day entered the meeting at this time.

OPERATOR'S REPORT

Ms. Hollingsworth presented to and reviewed with the Board the Operations Report dated January 13, 2025, a copy of which is attached is attached hereto as **Exhibit D**. She advised the Board that there are three (3) delinquent accounts totaling \$442.19, which MDS has been unable to collect. She advised that MDS recommends these accounts be turned over to collections for further collection efforts. Following discussion, Director Feiler moved that MDS be authorized to turn over the subject accounts to collections for further collection efforts, as discussed and as reflected in the Operations Report. Director Battistini seconded said motion, which unanimously carried.

ENGINEERING REPORT

Mr. Bozoarth next presented to and reviewed with the Board an Engineering Report dated January 9, 2025, a copy of which report is attached hereto as **Exhibit E**, relative to the status of various engineering and construction projects within the District. Upon review, Director Walker moved that the Engineering Report and all actions noted therein be approved as recommended by Quiddity, including acceptance and approval of (a) Quitclaim Conveyance of Utility Facilities (Water, Sanitary and Drainage Facilities to serve Sunterra Sections 67 and 68), and (b) Special Warranty Deed conveying certain recreational site(s) located within the District. Director Battistini seconded the motion, which unanimously carried.

REVISED EXHIBIT TO MAINTENANCE AGREEMENT RELATING TO RECREATIONAL FACILITIES

The Board next considered approval of a revised exhibit to the Maintenance Agreement between the District and Sunterra Property Owners Association, Inc., a copy of which is attached hereto as **Exhibit F**. Following discussion, Director Walker moved that the Board approve the revised exhibit and authorize the President to execute same on behalf of the Board and the District. Director Battistini seconded the motion, which unanimously carried.

SILT SOLUTIONS, INC.

The Board next considered a report from Silt Solutions, Inc. ("SSI") in connection with storm water pollution and prevention services. Ms. Cole advised that SSI provided a report for the period December 16, 2024 through January 6, 2025, a copy of which is attached hereto as **Exhibit G**.

LANDSCAPE ARCHITECURE REPORT(S)

Ms. Wilkes presented to and reviewed with the Board a monthly report prepared by K&W regarding the status of various recreational projects, a copy of which report is attached hereto as **Exhibit H**. Following discussion, Director Walker moved that K&W's report and all actions noted therein be approved as recommended by K&W. Director Battistini seconded the motion, which

BOOKKEEPER'S REPORT AND QUARTERLY INVESTMENT REPORT

Ms. Abad presented to and reviewed with the Board the Bookkeeper's Report, dated January 13, 2025, attached hereto as **Exhibit I**, including the disbursements presented for payment, as prepared by MA&C. Ms. Abad also presented to and reviewed with the Board a Quarterly Investment Inventory Report for the investment period ended November 30, 2024, a copy of which report is included in the Bookkeeper's Report. After discussion, it was moved by Director Day that (i) the Bookkeeper's Report be approved, and that the disbursements identified in the Bookkeeper's Report be authorized for payment, and (ii) the Quarterly Investment Report for the investment period ended November 30, 2024, be approved as presented, and the Investment Officers of the District be authorized to execute same on behalf of the Board and the District. Director Battistini seconded said motion, which unanimously carried.

DEVELOPER'S REPORT; PUBLIC FINANCE AUTHORITY TEXAS INFRASTRUCTURE PROGRAM TAX EXEMPT REVENUE ANTICIPATION IMPROVEMENT AND REFUNDING BONDS

Ms. Cole next addressed the Board concerning the Wisconsin Public Finance Authority Texas Infrastructure Program Tax Exempt Revenue Anticipation Improvement and Refunding Bonds, Series 2025 (the "Series 2025 Bonds"). In that regard, she advised the Board that the Public Finance Authority (the "PFA"), which is a unit of government and a public body corporate and politic of the State of Wisconsin, will issue the Series 2025 Bonds, and that the proceeds from the bonds will be disbursed to Astro Sunterra. Ms. Cole reported that, as security, Astro Sunterra will assign all of its future receivables due from the District to the PFA. Ms. Cole then presented to and reviewed with the Board various documentation for approval by the Board in connection with the Series 2025 Bonds, including: (i) correspondence from the District addressed to the PFA consenting to the transaction in order to satisfy the State of Wisconsin statutes; (ii) an Acknowledgment and Consent to Sale and Assignment Agreement by and between Astro Sunterra. the PFA, and Computershare Trust Company, N.A. (as trustee for the PFA); and (iii) a District Certificate. Copies of the documentation set forth above are attached hereto as Exhibit J. After discussion on the matter, Director Battistini moved that: (i) all documentation presented by Ms. Cole in connection with the Series 2025 Bonds be approved, subject to final review, and that the President be authorized to execute same on behalf of the Board and the District, to be held in escrow pending the closing on the Series 2025 Bonds tentatively scheduled for March 2025; and (ii) the President be authorized to execute any other documentation required to close the transaction. Director Day seconded said motion, which unanimously carried.

SECURITY PATROL REPORT

Ms. Cole presented to and reviewed with the Board the Security Patrol Report prepared by On-Site Services, LLC ("On-Site") for the month of December 2024, a copy of which is attached hereto as **Exhibit K**. She advised that the District is in receipt of correspondence from On-Site, a copy of which is included as part of **Exhibit K**, advising of a 9.9% increase in the rate for police patrol, effective as of February 15, 2025, in connection with the U.S. Bureau of Labor Statistics'

adjustment to current State Occupational Employment and Wage Estimates for Texas.

DISTRICT INSURANCE POLICIES

The Board next discussed the renewal of the District's insurance policies and authorizing the solicitation of proposals for same. Ms. Cole advised the Board that the District's current insurance policies, brokered through McDonald & Wessendorff ("McDonald"), will expire on March 31, 2025. After discussion concerning the various options available to the District, it was moved by Director Feiler, seconded by Director Battistini and unanimously carried, to authorize SPH to solicit a renewal proposal from McDonald to be reviewed and discussed at the next Board meeting.

ORDER ESTABLISHING POLICY FOR COVERED APPLICATIONS AND PROHIBITED TECHNOLOGY

The Board considered the adoption of an Order Establishing Policy for Covered Applications and Prohibited Technology ("Technology Policy"), a copy of which is attached hereto as **Exhibit L**. Ms. Cole advised that Senate Bill 1893, as passed during the 88th Regular Session, requires that all political subdivisions of the state, including the District, adopt a policy that prohibits the installation of certain social media applications, defined as "covered applications", on electronic devices owned or leased by the District. She noted that the social media application TikTok and any other software owned by ByteDance Limited are considered covered applications and may not be installed or used on a District owned or leased device. Ms. Cole further advised that the proposed Technology Policy mirrors the model policy created for governmental entities created by the Texas Department of Information Resources ("DIR"), and will be updated as needed to comply with the recommendations of DIR. After discussion on the matter, Director Feiler moved that the Technology Policy be adopted, and that the President and Secretary (or Assistant Secretary) be authorized to execute the same. Director Battistini seconded said motion, which unanimously carried.

ATTORNEY'S REPORT

The Board next considered the attorney's report. In connection therewith, Ms. Cole presented correspondence from Baird relative to disclosure requirements imposed by the Municipal Securities Rulemaking Board's Rule G-42, a copy of which is attached hereto as **Exhibit M**. After discussion, the Board concurred to formally acknowledge receipt of such disclosures.

FUTURE AGENDA ITEMS

The Board considered items for placement on future agendas. No items were requested to be added to future agendas other than those items discussed hereinabove.

ADJOURNMENT

There being no further business to come before the Board, on motion made by Director Feiler, seconded by Director Battistini, and unanimously carried, the meeting was adjourned.

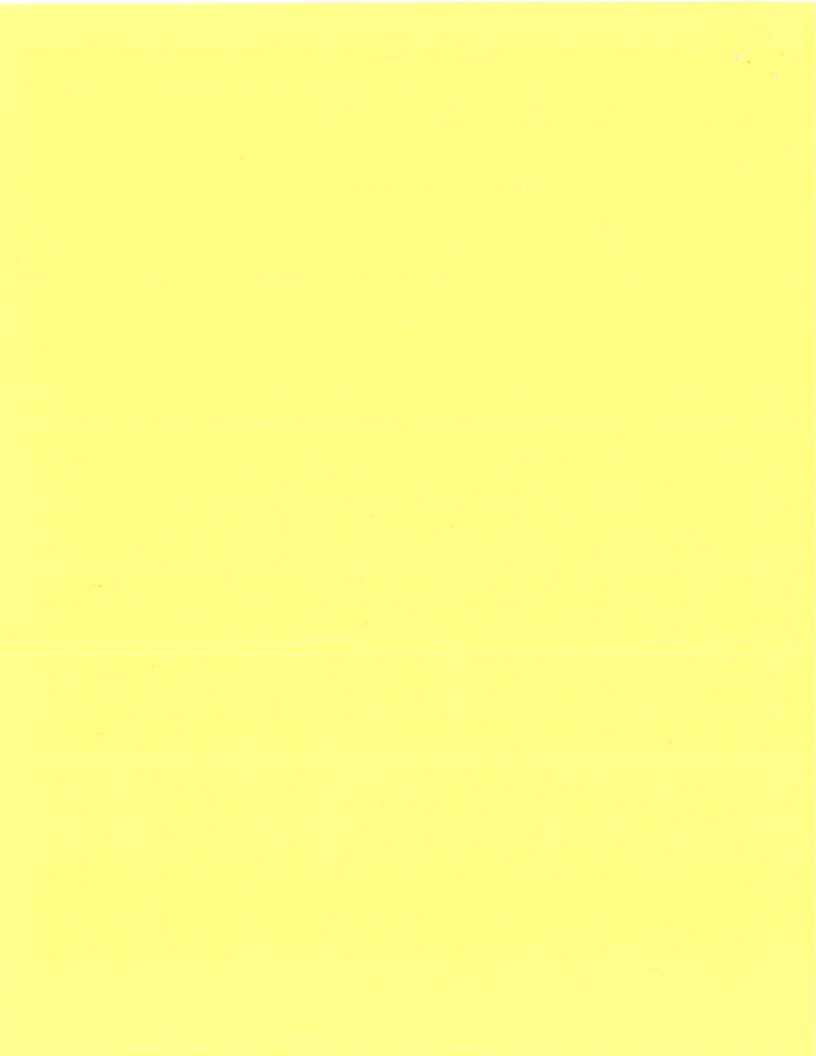

RESOLUTION CONCERNING EXEMPTIONS FROM TAXATION

WHEREAS, the laws of the State of Texas provide, under certain circumstances, for the exemption of a portion of the value of residence homesteads from ad valorem taxation; and

WHEREAS, the Board of Directors of Waller County Municipal Utility District No. 35 (the "District") has considered the various exemptions which may be granted. Now, Therefore,

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF WALLER COUNTY MUNICIPAL UTILITY DISTRICT NO. 35, THAT:

Section 1: For the tax year 2025, the Board of Directors has considered and has decided not to exempt from ad valorem taxation by the District any portion of the appraised value of residence homesteads of individuals who are under a disability for purposes of payment of disability insurance benefits under Federal Old-Age, Survivors, and Disability Insurance or are sixty-five (65) years of age or older, as authorized by, and in accordance with the provisions of, Article 8, Section 1-b (b), Texas Constitution, as amended, and Section 11.13 of the Tax Code, as amended.

Section 2: For the tax year 2025, the Board of Directors has considered and has decided not to adopt a general residential homestead exemption as authorized by Article 8, Section 1-b(e), Texas Constitution, as amended, and Section 11.13 of the Tax Code, as amended.

<u>Section 3</u>: This Resolution constitutes official action by the Board of Directors of the District concerning the foregoing tax exemptions.

Exhibit C

RESOLUTION AUTHORIZING AN ADDITIONAL PENALTY ON DELINQUENT PERSONAL PROPERTY TAXES

WHEREAS, the Board of Directors of Waller County Municipal Utility District No. 35 (the "District") is desirous of defraying the costs of collection of delinquent taxes; and

WHEREAS, the District has contracted with an attorney for collection of delinquent taxes as set forth in Section 6.30 of V.T.C.A. Tax Code, as amended ("Tax Code"); and

WHEREAS, Section 33.11 of the Tax Code, as amended, provides that, if the District has contracted with an attorney under Section 6.30 of the Tax Code, as amended, for collection of the District's delinquent taxes, the District may impose an additional penalty not to exceed the amount of the compensation specified in the contract with the attorney to be paid in connection with the collection of the delinquent personal property taxes on personal property taxes that become delinquent on or after February 1 of a year and that remain delinquent sixty (60) days after the date on which they become delinquent; and

WHEREAS, said Section 33.11 provides that said penalty shall not exceed the amount of compensation specified in the contract with the above-described attorney; and

WHEREAS, said contract specifies compensation in the amount of twenty percent (20%) of the amount of delinquent tax, penalty and interest collected; Therefore,

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF WALLER COUNTY MUNICIPAL UTILITY DISTRICT NO. 35, THAT:

- Section 1. The District has entered into a contract with an attorney pursuant to Section 6.30 and in accordance with Section 33.11 of the Tax Code, as amended, for the collection of delinquent taxes, penalty and interest.
- Section 2. District taxes on personal property that become delinquent on or after February 1 of a year and that remain delinquent sixty (60) days after said date shall incur an additional penalty of twenty percent (20%) on the amount of such personal property taxes, penalty and interest to defray the costs of collection of said delinquent taxes, in accordance with Section 33.11 of the Tax Code, as amended.
- Section 3. The District's tax collector shall deliver a notice of delinquency and of the penalty imposed pursuant to Section 2 above to the property owner at least thirty (30) and not more than sixty (60) days before the date on which the penalty will be incurred in the manner required by Section 33.11 of the Tax Code, as amended.
- <u>Section 4</u>. Delinquent personal property taxes which incur the penalty set forth in this Resolution shall not be subject to an additional penalty under Section 33.07 of the Tax Code, as amended, it being found and declared by the Board of Directors of the District that the penalty hereunder is an alternative to the authority of said Section 33.07.

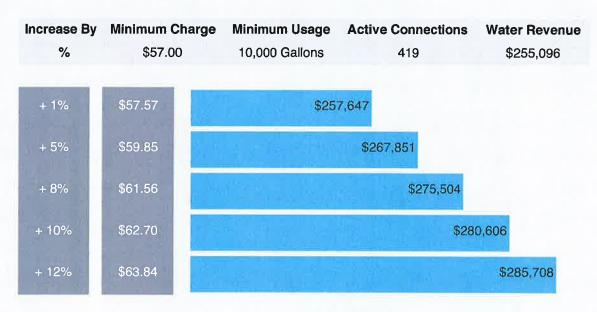

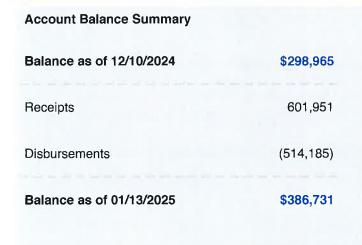
Account Balance By Month | January 2024 - December 2024

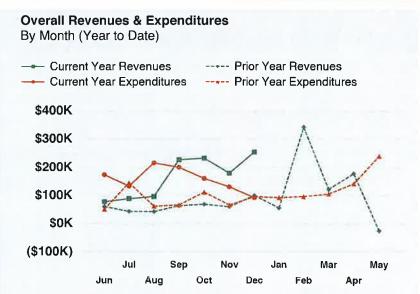

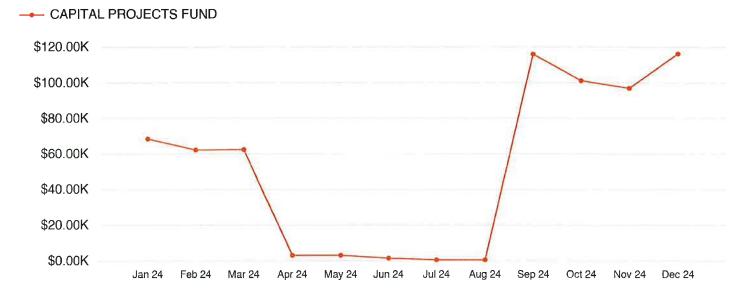
Monthly Financial Summary - Capital Projects Fund







Account Balance By Month | January 2024 - December 2024



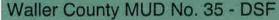

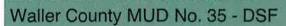

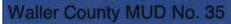

Investment Profile as of 01/13/2025



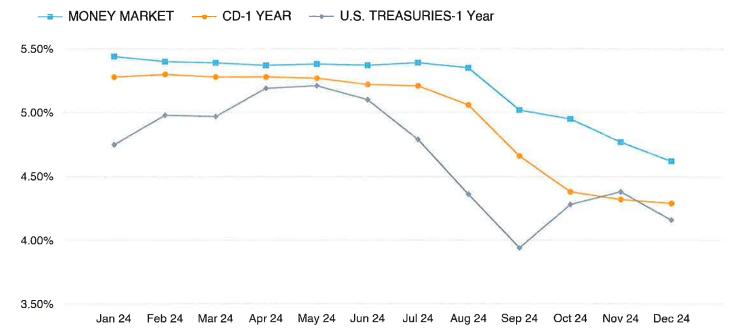


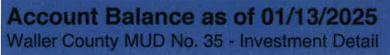

Ladies and Gentlemen:

Waller County Municipal Utility District No. 35, a political subdivision of the State of Texas (the "District") has been informed that the Public Finance Authority (the "PFA"), proposes to issue its tax-exempt revenue anticipation bonds in the aggregate principal amount not to exceed \$200,000 (the "Bonds"), the proceeds of which will finance multiple municipal utility district projects in Texas, including one or more projects located within the District in Waller County, Texas, consisting of the design, construction and acquisition of certain public infrastructure improvements including water, sewer, and drainage facilities, and road facilities to be located partially or fully within the boundaries of the District, and owned by the District or another governmental entity (the "Astro Texas Land Projects"). The Astro Texas Land Projects are being constructed pursuant to that certain (i) Amended and Restated Utility Development Agreement (Water, Sanitary Sewer, and Drainage Facilities), by and between the District and Astro Sunterra, L.P. (the "Developer"), dated November 14, 2022, (ii) Amended and Restated Utility Development Agreement (Road Facilities), by and between the District and the Developer, dated November 14, 2022, and (iii) Amended and Restated Utility Development Agreement (Recreational Facilities), by and between the District and the Developer, dated November 14, 2022, pursuant to which the Developer agreed to construct the Project, and the District agreed to issue bonds (the "District Bonds") the proceeds of which would be paid to the Developer, subject to the terms and conditions of the Development Agreements, as reimbursement for payments made for the benefit of the District to construct eligible public infrastructure costs of the Project to be owned by the District or another governmental entity.

The District has been informed that the Bonds that are anticipated to be sold will be secured by the sale and assignment of the Developer's right to receive the future proceeds from the sale of certain District Bonds otherwise payable to the Developer pursuant to the terms of the Development Agreements.

The District has been further informed that Section 66.0304(11)(a) of the Wisconsin Statutes provides the PFA may not issue bonds to finance a capital improvement project unless the governing body, or the highest ranking executive or administrator, of a political subdivision

(defined to include any city, village, town, county, district, authority, agency, commission, or other similar governmental entity in another state or office, department, authority, or agency of such other state or territory of the United States) within whose boundaries the project is to be located, has approved the financing of the project.

Compliance by the District with Section 66.0304(11)(a) of the Act does not constitute an endorsement of the Bonds or the Project by the District, or a commitment by the District, or any other governmental body, to provide any other approvals that may be required in connection with the Project, or an undertaking of any responsibility of any kind with respect to the Bonds.

The potential benefits to the District from the proposed Project include the development of public infrastructure that will allow for access to new development that will increase the District's tax base including increased real property tax revenues.

As the [President] of the District, I am the highest-ranking executive of the District. Solely for purposes of satisfying the requirements of Section 66.0304(11)(a) of the Wisconsin Statutes, I hereby provide this letter as evidence of approval of the above-described financing by the District, but in no other way provide any opinion or endorsement with respect to the issuance of the Bonds. This letter does not constitute a commitment by the District, or any other governmental body, to provide any other approvals that may be required in connection with the above-described Project, or an undertaking of any responsibility of any kind with respect to the Bonds. This letter shall not be referred to in connection with the marketing and sale of the Bonds.

ACKNOWLEDGMENT AND CONSENT TO SALE AND ASSIGNMENT AGREEMENT Astro Sunterra, L.P.

Waller County Municipal Utility District No. 35 (the "District") is delivering this document with respect to the issuance of the Public Finance Authority Texas Infrastructure Program Tax-Exempt Revenue Anticipation Improvement and Refunding Bonds (Astro Texas Land Projects), Series 2025 (the "Bonds"). Terms not otherwise defined herein have the meaning ascribed thereto in the foregoing Sale and Assignment Agreement (the "Sale Agreement"). Subject to issuance of the Bonds, the District hereby:

- (i) consents to the sale and assignment by the Developer of the Reimbursement;
- (ii) agrees that, (A) pursuant to the sale and assignment of the Reimbursement under the Sale Agreement and as directed by the Developer, it will pay any moneys due to the Developer under the Reimbursement Agreement relating to the Reimbursement directly to the Trustee, as assignee of the Issuer, until such time as the District is otherwise notified in writing by TIP Management Company LLC; provided, however, that the District shall have the unqualified right, without incurring any liability to the Issuer, the Trustee, Developer, or any of their respective successor and assigns, or any deemed third party beneficiaries of the payment of the Reimbursement to Trustee, to interplead the Reimbursement (or any portion thereof) into the registry of a court with jurisdiction in the event there are competing claims, disputes, protests, challenges, or similar matters asserted by any person or entity concerning or related to the Reimbursement, or any portion thereof, or the payment of such Reimbursement to Trustee (as the assignee of the Issuer), and (B) only to the extent required by law and the provisions of the Reimbursement Agreement, the obligation of the District to reimburse Developer under the Reimbursement Agreement shall survive the termination of the Reimbursement Agreement for any Public Infrastructure authorized under the Reimbursement Agreement that is constructed, acquired, equipped or otherwise provided by Developer or others and accepted by the District. The foregoing provisions shall not be construed to obligate the District to issue its bonds or to otherwise pay any monies to the Trustee which the District is not otherwise legally obligated to pay upon termination of the Reimbursement Agreement;
- (iii) agrees that Developer's right to Reimbursement under the Reimbursement Agreement, as assigned hereunder, shall have priority over and be senior to reimbursement owed to any other entity or person under said Reimbursement Agreement, other than as specifically set forth in the Reimbursement Agreements; and
- (iv) represents and certifies that as of the date hereof it reasonably expects that (A) the Public Infrastructure authorized under the Reimbursement Agreement that is funded by the Developer or others pursuant to the Reimbursement Agreement and accepted by the District will be owned, operated, and maintained by the [[_______], Texas], the District or other political subdivisions of the State of Texas; (B) the Public Infrastructure authorized under the Reimbursement Agreement that is funded by the Developer or others and accepted by the District will serve customers within the District; (C) other than (1) contracts or arrangements with a political subdivision of the State of Texas or (2) contracts or arrangements with another "Service Provider," which contracts or arrangements are described by Treasury Regulation 1.141-

3(b)(4)(iii)(C) or meet the requirements of Revenue Procedure 2017-13, the District has not entered and will not enter into any contract or arrangement to operate, maintain and/or lease any portion of the Public Infrastructure authorized under the Reimbursement Agreement that is funded by Developer or others pursuant to the Reimbursement Agreement and accepted by the District; and (D) the District will not authorize any agreement or use of the Public Infrastructure authorized under the Reimbursement Agreement that is funded by the Developer or others pursuant to the Reimbursement Agreement and accepted by the District that will cause the Bonds to meet the "private business tests" as such term is defined in Section 1.141-1(b) of the Internal Revenue Code of 1986. The District expressly disclaims any representation or certification relating to the ownership, operation, maintenance or use of any portion of the Project prior to its conveyance to the District, as may be applicable, for any Project facilities that are not Public Infrastructure accepted by the District, or for any portion of the Project after its conveyance to other entities

Nothing herein shall be construed to limit the District's ability to issue bonds to finance District water, sewer, drainage or road infrastructure improvements without developer funding, or with funding by developers other than Developer, that may be necessary to serve lands within the District.

By its execution of this Acknowledgment, the District disclaims any representations as to (i) the validity of the Sale Agreement, and (ii) whether Issuer and/or Developer have satisfied the terms and conditions set forth in the Reimbursement Agreement which must be satisfied prior to the accrual of the District's obligation to pay any sum or sums due, or to become due, under the Reimbursement Agreement.

The District expressly disclaims any acknowledgment or approval of (i) the terms of any instruments relating to the sale or issuance of the Bonds, including but not limited to the Indenture, (ii) the terms of the Program Agreement and (iii) the content of any offering documents or private placement memoranda relating to the sale of the Bonds, and the District shall have no responsibility whatsoever therefor. The District further disclaims any representation as to any federal, state, or local tax consequences resulting from the ownership of, receipt or accrual of interest on, or disposition of the Bonds. The District expressly disclaims any representation as to the excludability from gross income of interest on the Bonds for federal income tax purposes.

Notwithstanding any provision herein to the contrary, under no circumstances shall the District be responsible for payment of any monies in connection with the issuance of the Bonds. This instrument shall not be construed to expand any obligation of the District to issue its bonds or to pay monies to any person or entity; and the District's obligation to pay monies to the Trustee, as assignee of the Issuer, shall in all respects be limited to the District's obligation to pay monies otherwise due to the Developer under the Reimbursement Agreement.

The agreements, representations, consents and certifications set forth hereunder shall terminate for all purposes on the date that is the earlier of (i) the date that the District is notified in writing by TIP Management Company LLC that direct payments to the Trustee by the District are no longer due or required under the arrangement between the Issuer and the Developer and (ii) the date that the Sale Agreement is null and void in accordance with Section 5 thereof.

The District shall have no obligation to pay the Reimbursement to the Issuer or Trustee unless (i) the terms and conditions set forth in the Reimbursement Agreement have been met; and (ii) the Issuer, Trustee, Developer, or their respective successor and assigns, have executed and delivered a receipt to the District in form attached hereto as <a href="Exhibit "A" in which the Issuer, Developer, or other duly appointed successors or assigns represent and warrant that the Trustee (or the assignee, if applicable) is entitled to receive the Reimbursement (or applicable portion thereof) and no other person or entity is entitled to or has a claim to same. For the avoidance of doubt, nothing herein or in the Sale Agreement shall obligate the District to pursue a bond validation suit or similar legal action in connection with the issuance of the District bonds in the event the Texas Attorney General has not approved such issuance as a result of any action, inaction, or omission of the Trustee or the Issuer.

Developer hereby represents and warrants that it has not assigned or attempted to assign any of its right, title, interest, or benefit in and under the Reimbursement Agreement and which is assigned by the Sale Agreement to any other person or entity, other than Issuer. In consideration of the District's execution of this Acknowledgment, DEVELOPER HEREBY AGREES TO INDEMNIFY, DEFEND AND HOLD THE DISTRICT HARMLESS FROM AND AGAINST ANY AND ALL LOSS, COST, EXPENSE OR LIABILITY (INCLUDING REASONABLE ATTORNEYS' FEES), ARISING OUT OF OR IN ANY WAY RELATED TO (I) DEVELOPER'S BREACH OF THE FOREGOING REPRESENTATION AND WARRANTY, AND (II) ANY CLAIMS, LAWSUITS, JUDGMENTS, DISPUTES, PROTESTS, CHALLENGES AND SIMILAR MATTERS ASSERTED BY DEVELOPER AS TO ANY SUM OR SUMS DUE, OR TO BECOME DUE, UNDER THE REIMBURSEMENT AGREEMENT. DEVELOPER ADDITIONALLY AGREES TO PAY ALL REASONABLE ATTORNEYS FEES AND EXPENSES INCURRED BY THE DISTRICT WHICH ARISE OUT OF OR ARE IN ANY WAY RELATED TO A BREACH OF THE FOREGOING REPRESENTATIONS AND WARRANTIES.

The foregoing indemnities and hold harmless agreements running in favor of the District are specifically intended to cover all costs of the District for any future litigation, including attorneys' fees and expenses, other defense costs, and the costs of enforcing the indemnities and hold harmless agreements.

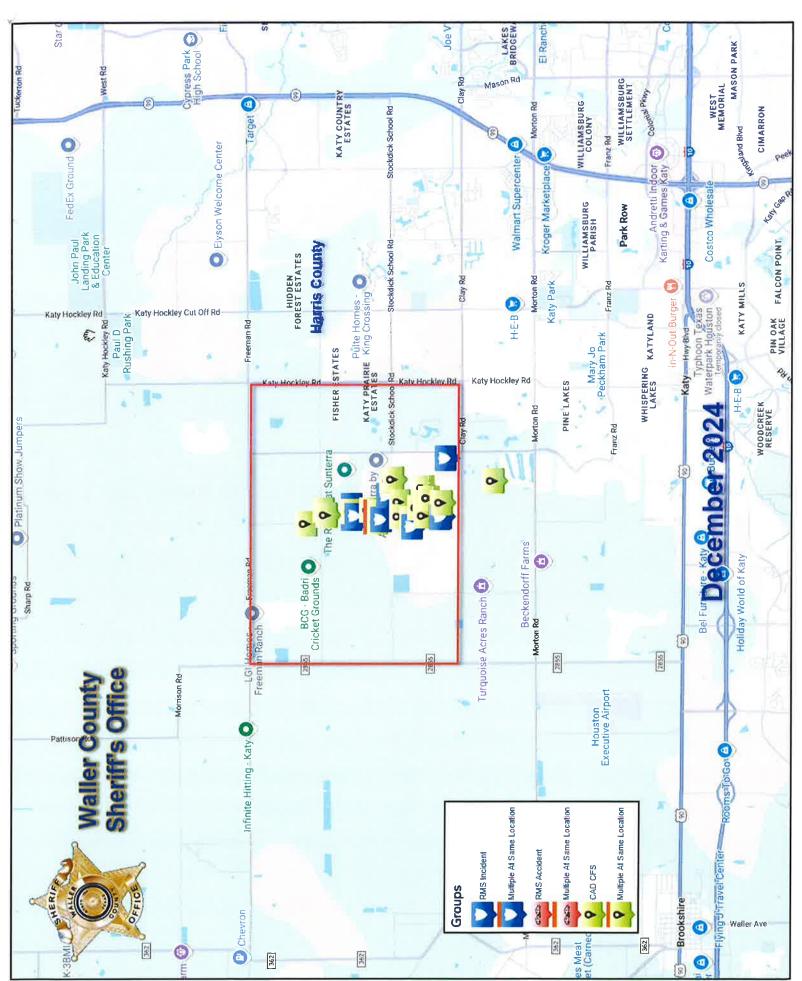

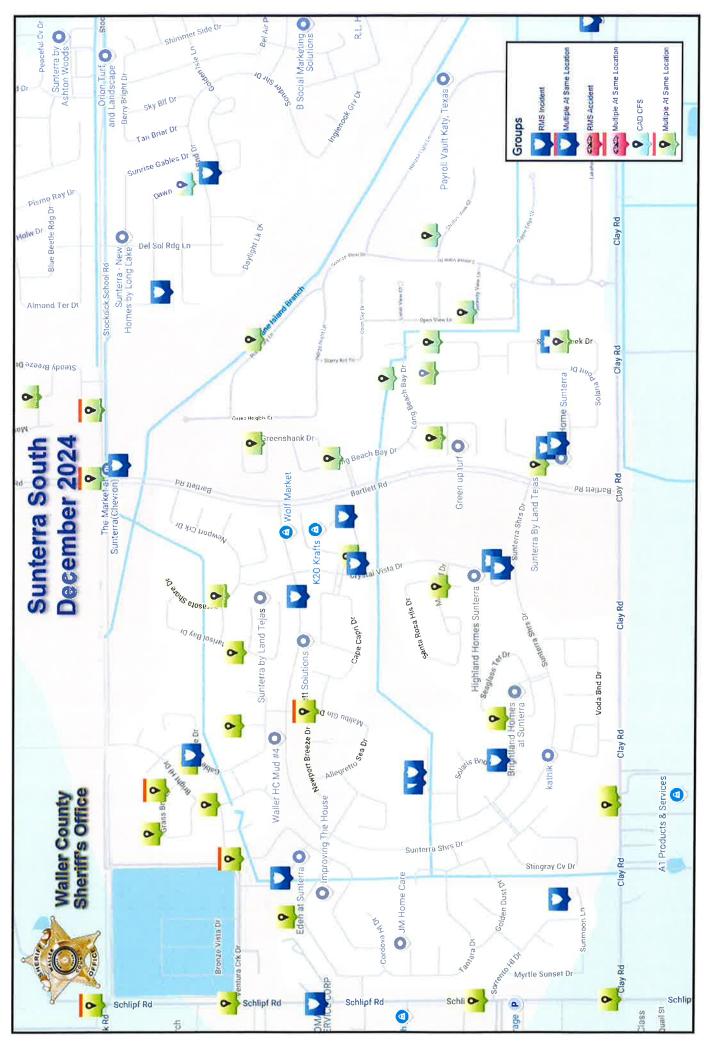

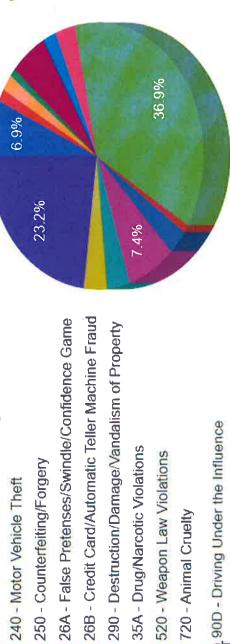

Police Patrol Hourly Rate Adjustment

Dear Board of Directors:

On-Site Protection has been pleased to provide Waller County MUD No. 35 with ongoing security consulting services and the coordination of police patrol. We are likewise committed to continuing to provide these services to the District in the future.

Pursuant to Section 4 of our current Security Consulting Services Agreement, On-Site is entitled to amend its fee schedule annually based on the most current State Occupational Employment and Wage Estimates for Texas, as published by the U.S. Bureau of Labor Statistics ("BLS Wage Estimates"). BLS Wage Estimates for Police Officers published April 2024 show an increase of 10.6% over those published in April 2023. In accordance with this increase, we request a 9.9% increase in the District's current rate for police patrol. The rate of \$58.68 (established 3/13/23) shall therefore increase to \$64.50, effective February 15, 2025.

Enclosed please find Revision 1 of Exhibit A (Security Consulting Rate and Fee Schedule) of the District's current Security Consulting Services Agreement. This revision shows the new rate and replaces the existing version of Exhibit A. Please note that this increase does NOT affect the security budget set by the District. It merely increases the rate paid per hour for patrol services. We will continue to work within the budget currently in place. On-Site appreciates the opportunity to provide you with security services and will continue to provide you with the service you expect. Please contact me should you have any questions.

SECURITY CONSULTING RATE AND FEE SCHEDULE

(REVISED -- EFFECTIVE FEBRUARY 15, 2025)

The following is a breakdown of rates and fees to be charged by OSP:

Security Consultant Fee

\$950.00 per month

Uniformed, Licensed Peace Officers for Traffic Control and Visible Deterrence (4-hour minimum per assignment)

\$64.50 per hour

Notwithstanding the foregoing, OSP will charge 1.5 (one and one-half) times the billing rate for all Peace Officer hours worked on the following national holidays: New Year's Day, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Day after Thanksgiving, Christmas Eve, Christmas Day, and New Year's Eve.

These rates will be in effect for year one (1) of the contract. For subsequent years, the rates may be adjusted based on the most current BLS Wage Estimates and with prior written notice to the District.

ORDER ESTABLISHING POLICY FOR COVERED APPLICATIONS AND PROHIBITED TECHNOLOGY

WHEREAS, WALLER COUNTY MUNICIPAL UTILITY DISTRICT NO. 35 (the "District") is a body politic and corporate and a governmental agency of the State of Texas, operating under and governed by the provisions of Chapters 49 and 54 of the Texas Water Code, as amended, and Section 59 of Article XVI of the Texas Constitution; and

WHEREAS, Chapter 620 of the Texas Government Code requires that the Board of Directors of the District adopt a policy prohibiting the use and requiring the removal of certain social media applications and services on devices owned or leased by the District;

NOW, THEREFORE, IT IS ORDERED BY THE BOARD OF DIRECTORS WALLER COUNTY MUNICIPAL UTILITY DISTRICT NO. 35, THAT the policies, procedures and provisions set forth in the Covered Applications and Prohibited Technology Policy attached hereto as "Exhibit A" be and are hereby ADOPTED.

COVERED APPLICATIONS AND PROHIBITED TECHNOLOGY POLICY

I. PURPOSE, DEFINITIONS AND REQUIREMENTS

A. Purpose

The Board of Directors of Waller County Municipal Utility District No. 35 (the "District") have established this Covered Applications and Prohibited Technology Policy to prohibit the use of certain social media applications and services, including, but not limited to, TikTok and any successor application developed by ByteDance, on devices owned or leased by the District in compliance with Chapter 620 of the Texas Government Code.

B. Scope and Definitions

This policy applies to any and all District full- and part-time employees, contractors, paid or unpaid interns, and other users of District networks. All users of District networks or District owned or leased devices are responsible for complying with this policy.

A covered application is:

- 1. The social media service TikTok or any successor application or service developed or provided by ByteDance Limited, or an entity owned by ByteDance Limited.
- 2. A social media application or service heretofore or hereafter specified by proclamation of the governor under Section 620.005, Government Code.

C. Covered Applications on District-Owned or Leased Devices

Except where approved exceptions apply, the use or installation of covered applications is prohibited on all District-owned or -leased devices, including cell phones, tablets, desktop and laptop computers, and other internet-capable devices.

The District will identify, track, and manage all District-owned or leased devices including mobile phones, tablets, laptops, desktop computers, or any other internet-capable devices to:

- a. Prohibit the installation of a covered application;
- b. Prohibit the use of a covered application;
- c. Remove a covered application from a District-owned or -leased device that was on the device prior to the passage of S.B. 1893 (88th Leg, R.S.); and
- d. Remove an application from a District-owned or -leased device if the Governor issues a proclamation identifying it as a covered application.

The District will manage all District-owned or -leased mobile devices by implementing one or more of the security measures listed below:

- a. Restrict access to "app stores" or unauthorized software repositories to prevent the installation of unauthorized applications;
- b. Maintain the ability to remotely wipe non-compliant or compromised mobile devices;
- c. Maintain the ability to remotely uninstall unauthorized software from mobile devices; and
- d. Conduct reviews of District-owned or -leased devices to detect and remove covered applications.

D. Ongoing and Emerging Technology Threats

To provide protection against ongoing and emerging technological threats to the District's sensitive information and critical infrastructure, the Texas Department of Public Safety (DPS) and the Texas Department of Information Resources (DIR) will regularly monitor and evaluate additional social media applications or services that pose a risk to this state.

DIR will annually submit to the Governor a list of social media applications and services identified as posing a risk to Texas. The Governor may proclaim items on this list as covered applications that are subject to this policy.

If the Governor identifies an item on the DIR-posted list described by this section, then the District will remove and prohibit the covered application. The District may also prohibit social media applications or services in addition to those specified by proclamation of the Governor.

E. Bring Your Own Device Policy

The District has not implemented a "Bring Your Own Device" (BYOD) program. Should the District implement a BYOD program, then the District may prohibit the installation or operation of covered applications on employee-owned devices that are used to conduct District business.

F. Covered Applications Exceptions

The District has not permitted exceptions authorizing the installation and use of a covered application on District owned or leased devices consistent with the authority provided by Chapter 620, Government Code.

II. POLICY COMPLIANCE

The District will verify compliance with this policy through various methods, including but not limited to, information technology and security system reports and feedback to leadership.

III. POLICY REVIEW

This policy will be reviewed and updated as necessary to reflect changes in state law or to suit the needs of the District.

Accordingly, Baird makes the following disclosures with respect to material conflicts of interest in connection with the Services under the Agreement, together with explanations of how Baird addresses or intends to manage or mitigate each conflict. This conflict of interest is mitigated by the general mitigations described herein.
- Municipal Advisory Fees contingent upon completion of a Financing and in a fixed amount may give Baird an incentive to recommend to the Client a Financing that is unnecessary or to recommend less time-consuming alternatives or limit its analysis of alternatives because fixed fees are usually based upon an analysis by the Client and Baird of, among other things, the expected duration and complexity of the transaction and the Scope of Services to be performed by Baird and if the transaction requires more work than originally contemplated, Baird may suffer a loss. This conflict of interest is mitigated by the general mitigations described herein.
- Municipal Advisory Fees based on hourly fees of Baird's personnel, with the aggregate amount equaling
 the number of hours worked by such personnel times an agreed-upon hourly billing rate presents a potential
 conflict of interest if the Client and Baird do not agree on a reasonable maximum amount at the outset of
 the engagement, because Baird does not have a financial incentive to recommend alternatives that would
 result in fewer hours worked. This conflict of interest is mitigated by the general mitigations described
 herein.

While we do not believe that the following creates a conflict of interest on Baird's part, we note that spouses or other relatives of Baird Associates may serve as an officer, employee or official of Client. Client may wish to consider any impact such circumstances may have on how it conducts its activities with Baird under this Agreement.

Baird associates, including Baird Public Finance associates, may have made or may make political contributions to elected officials and/or candidates for office, including officials of the Client in compliance with MSRB Rule G-37 and Baird's internal policies and pre-clearance requirements.

Baird is registered with the Municipal Securities Rulemaking Board ("MSRB") and the SEC. The MSRB website is www.msrb.org. Two investor brochures, Information for Municipal Securities Investors and Information for Municipal Advisory Clients, describe the protections that may be provided by the MSRB's rules. The brochures are available on the MSRB website. The MSRB website also contains information about how to file a complaint with an appropriate regulatory authority.

<u>Disclosures of Information Regarding Legal Events and Disciplinary History.</u> MSRB Rule G-42 requires that municipal advisors provide to their clients certain disclosures of legal or disciplinary events material to its client's evaluation of the municipal advisor or the integrity of the municipal advisor's management or advisory personnel.

Accordingly, Baird sets out below required disclosures and related information in connection with such disclosures. Baird discloses the following legal or disciplinary events that may be material to Client's evaluation of Baird or the integrity of Baird's management or advisory personnel:

• In September 2023, Baird entered into an Offer of Settlement with the SEC (the "Settlement"), in which it admitted that it violated Section 17(a) of the Securities Exchange Act of 1934 (the "Exchange Act") and Rule 17a-4(b)(4) thereunder and Section 204 of the Investment Advisers Act of 1940 (the "Advisers Act") and Rule 204-2(a)(7) thereunder for failing to maintain records of certain business-related communications made by Baird associates when they used their personal devices ("off-channel communications") and for failing to supervise its associates' business-related communications. The Settlement was related to an SEC risk-based initiative, whereby the SEC investigated a large number of financial services firms to determine whether those firms were properly retaining business-related text and instant messages and other off-

Following the commencement of the SEC's initiative, Baird cooperated with the SEC and conducted voluntary interviews of a sampling of Baird supervisors to gather and review messages found on their personal devices. While Baird had policies and procedures in place prohibiting such off-channel communications, it was discovered that certain Baird supervisors communicated off-channel using non-Baird approved methods on their personal devices about Baird's broker-dealer and investment adviser businesses, and the findings were reported to the SEC. Baird took steps prior to and after the SEC's review, including implementing a new communication tool designed for Baird associates' personal devices, conducting training, and periodically requiring requisite associates to provide an attestation relating to their business-related communications. As part of the Settlement, Baird was censured and ordered to cease and desist from future violations of Section 17(a) of the Exchange Act and Rule 17a-4(b)(4) thereunder and Section 204 of the Advisers Act and Rule 204-2(a)(7) thereunder and to pay a civil monetary penalty of \$15 million. In addition, Baird agreed to certain undertakings, including retaining an independent compliance consultant to conduct a review of Baird's policies and procedures, training, surveillance program, technology solutions and similar matters related to off-channel communications. - In August 2022, Baird, without admitting or denying the findings, consented to the entry of findings of FINRA, which found that it charged certain customers an unfair commission by charging its published minimum commission amount of \$100 on certain small equity trades and failed to establish and maintain a supervisory system reasonably designed to prevent charging a customer a commission that is unreasonable or unfair in violation of FINRA Rules. The findings related to FINRA's routine examination of Baird in 2020. In response to the routine examination, Baird modified its minimum commission schedule and supervisory procedures, and took steps to make payments to the affected customers. Baird also continues to make efforts to ensure that it charges fair prices and commissions on all securities transactions with its customers. This matter relates primarily to Baird's Private Wealth Management department and does not involve or pertain in any way to Baird's Public Finance business or municipal advisory activities or services. The details of this matter are available under "Regulatory Final" in Baird's BrokerCheck report available at https://brokercheck.finra.org/.
- In December 2021, Baird, without admitting or denying the findings, consented to the sanctions and findings of New York Stock Exchange LLC (the "NYSE") that, on June 11, 2018 Baird received orders from an institutional customer to buy an equity security and routed those orders to different NYSE floor broker firms, in violation of NYSE Rule 122, which prohibits firms from sending to more than one floor broker orders at the same price for the purchase or sale of the same security with knowledge that such orders are for the account of the same customer. In connection with its violation, Baird failed to establish and maintain a supervisory system and written supervisory procedures reasonably designed to achieve compliance with NYSE Rule 122. This matter relates to Baird's Institutional Equity Trading department and does not involve or pertain in any way to Baird's Public Finance business or municipal advisory activities or services. The details of this matter are available in item 11.E (2) and the accompanying Regulatory Action DRP on Baird's Form ADV available at http://www.adviserinfo.sec.gov.
- In June 2019, Baird, without admitting or denying the findings, consented to the sanctions and findings of FINRA that, between April and July 2013, Baird published equity research reports about an issuer without disclosing that the research analyst who authored the reports was engaged in employment discussions with the issuer that constituted an actual, material conflict of interest and that the failure to disclose the research analyst's employment discussions with the issuer in the research reports made those reports misleading. In response, Baird took proactive measures to reiterate compliance policies pertain to disclosures about material conflicts of interest in research reports. This matter relates to Baird's Equity Research department and does not involve or pertain in any way to Baird's Public Finance business or municipal advisory activities or services. The details of this matter are available in item 11.E (2) and the accompanying Regulatory Action DRP on Baird's Form ADV available at http://www.adviserinfo.sec.gov.
- In March 2019, Baird, without admitting or denying the findings, consented to an order of the SEC, which found that it violated Sections 206(2) and 207 of the Investment Advisers Act of 1940 (the "Advisers Act")

for making inadequate disclosures to advisory clients about mutual fund share classes. The order was part of a voluntary self-reporting program initiated by the SEC called the "Share Class Selection Disclosure (or SCSD) Initiative." Under the program, investment advisory firms were offered the opportunity to voluntarily self-report violations of the federal securities laws relating to mutual fund share class selection and related disclosure issues and agree to settlement terms imposed by the SEC, including returning money to affected investment advisory clients. The central issue identified by the SEC was that, in many cases, investment advisory firms bought for or recommended to their investment advisory clients mutual fund share classes that had distribution or service fees (commonly known as 12b-1 fees) paid out of fund assets to the firms when lower cost share classes were available to those advisory clients, and the investment advisory firms did not adequately disclose their receipt of 12b-1 fees and/or the conflict of interest associated with those 12b-1 paying share classes. Baird and many other firms self-reported under the program and entered into substantially identical orders. By self-reporting and consenting to the order, Baird agreed to a censure and to cease and desist from committing or causing any violations and future violations of Sections 206(2) and 207 of the Advisers Act. Baird also agreed to establish a distribution fund and to deposit into that fund the improperly disclosed 12b-1 fees received by Baird plus prejudgment interest, which will be paid to affected advisory clients. In response, Baird has made changes to its Private Wealth Management advisory programs in which mutual funds available in those programs do not include share classes that pay 12b-1 fees, and the share classes that are available to clients in those programs are generally those that are the lowest cost share classes most widely available by each mutual fund family across its various funds to most types of eligible investors. This matter relates primarily to Baird's Private Wealth Management department and does not involve or pertain in any way to Baird's Public Finance business or municipal advisory activities or services. - Baird was among numerous municipal securities underwriters and municipal issuers that voluntarily participated in the Municipal Continuing Disclosure Cooperation Initiative (MCDC) facilitated by the Securities and Exchange Commission (SEC) in March 2014. Under the MCDC, underwriters and issuers were requested to submit reports to the SEC identifying municipal securities offerings for which the official statement did not accurately describe prior instances of the issuer's material non-compliance with its continuing disclosure requirements required by SEC Rule 15c2-12. By voluntarily participating in the MCDC. Baird and other underwriters and issuers agreed to accept standardized settlement terms. In June 2015, the SEC issued Orders to 36 participating municipal underwriters, including Baird, setting forth the agreed upon settlement terms. Subsequently, the SEC issued similar Orders to additional participating underwriters. Each Order, including the one applicable to Baird, contains a finding, which the underwriter neither admits nor denies, that Baird did not conduct adequate due diligence to ensure that the issuers' representations in the official statements about their past compliance with continuing disclosures were accurate and therefore violated Section 17(a)(2) of the Securities Act of 1933. Each Order requires the underwriter to cease and desist from committing or causing any violations or future violations of Section 17(a)(2), to pay a civil monetary penalty (which, in Baird's case, is \$500,000), to retain an independent consultant to review Baird's municipal underwriting due diligence policies and procedures, and to adopt the consultant's final recommendations for changes in or improvements to those policies and procedures. - In September 2016, Baird, without admitting or denying the findings, consented to the sanctions and findings of the SEC that Baird violated Section 206(4) of the Advisers Act and Rule 206(4)-7 thereunder by failing to adopt and implement adequate policies and procedures to track and disclose trading away practices by certain of the subadvisors participating in Baird's wrap fee programs offered through its Private Wealth Management department. Through these programs, Baird's advisory clients pay an annual fee in exchange for receiving access to select subadvisors and trading strategies, advice from Baird's financial advisors, and trade execution services through Baird at no additional cost. However, if a subadvisor chooses not to direct the execution of particular equity trades through Baird in order to fulfill its best execution obligation and the executing broker charges a commission or fee, Baird's advisory clients often are charged additional commissions or fees for those transactions, which is often embedded in the price paid or received for the security. This practice is referred to as "trading away" and these types of trades are frequently called "trade

aways." Baird was found to have failed to adopt or implement policies and procedures designed to provide specific information to Baird's clients and financial advisors about the costs of trading away. Baird agreed to provide additional disclosure to clients and review and, as necessary, update its policies and procedures. This matter relates to Baird's Private Wealth Management department and does not involve or pertain in any way to Baird's Public Finance business or municipal advisory activities or services. - In August 2013, Baird was involved in a regulatory matter with respect to Municipal Securities Rulemaking Board (MSRB) Rule G-14 involving trade reporting of municipal bond transactions executed by Baird for internal money managers on behalf of their clients. Baird reported the transactions on a bunched order quantity basis instead of individually by amount of allocation. Baird has since reviewed its municipal bond trade reporting methodology in this context and has revised its processes to more clearly reflect the requirements of the rule interpretations. The details of this matter are available in item 11.E (2) and the accompanying Regulatory Action DRP on Baird's Form ADV available at http://www.adviserinfo.sec.gov.
- In June 2013, Baird was involved in a regulatory matter involving a small number of transactions in comparison to Baird's total fixed income trading volume with respect to the purchase of municipal securities for its own account from customers and/or sold municipal securities for its own account to customers that was allegedly not fair and reasonable, taken into account all relevant factors related to MSRB Rules G-17 and G-30(A). Baird has taken steps to address this matter, including improving its systems to better monitor and document Baird's compliance with its best execution obligations; providing additional training to Baird's fixed income traders on their obligations to document the prices, quotations or indications received from counterparties to reflect for firm records the pricing in markets at the time of each transaction; and providing additional training to traders on their best execution obligations. - In November 2011, Baird was involved in a regulatory matter involving late submissions to the MSRB and the Electronic Municipal Market Access (EMMA). In response, all personnel in the municipal underwriting and public finance departments responsible for the filings attended additional MSRB training on primary market and advance refunding MSRB G-32 submissions, and Baird has amended its MSRB G-32 procedures by publishing additional guidance to appropriate personnel and installing new mechanisms to monitor the required filing and closing dates. - The SEC permits certain items of information required on Form MA or MA-I to be provided by reference to such required information already filed by Baird in its capacity as a broker-dealer on Form BD or Form U4 or as an investment adviser on Form ADV, as applicable. If any of the above DRPs provides that a DRP has been filed on Form ADV, BD, or U4 for the applicable event, information provided by Baird on Form BD or Form U4 is publicly accessible through reports generated by BrokerCheck at http://brokercheck.finra.org, and Baird's most recent Form ADV is publicly accessible at the Investment Adviser Public Disclosure website at http://www.adviserinfo.sec.gov.
