Minutes of Meeting of Board of Directors October 14, 2025

The Board of Directors ("Board") of Harris County Water Control and Improvement District No. 113 ("District") met on October 14, 2025, at 14707 Dale Hollow Lane, Cypress, Texas, 77429, pursuant to the duly posted notice of said meeting with a quorum of directors present as follows:

Also present were Ms. Michelle Guerrero of Bob Leared Interests; Mr. Scott Shelnutt of Municipal Operations & Consulting, Inc.; Mr. Christopher T. Burke of Burke Engineering; and Mr. Douglas McNiel, attorney for the District.

The President called the meeting to order and declared it open for such business as might properly come before it.

- 1. The Board opened the floor for public comment. Hearing none, the Board continued the meeting.
- 2. The Board opened a public hearing for the proposed 2025 tax rate at 7:09 p.m. The financial advisor recommended maintaining the current tax rate of \$0.57, composed of a \$0.070 debt service tax and a \$0.50 operations and maintenance tax. This will maintain a very healthy 32-and-a-half-month reserve in the District's operating fund. The engineer noted that the District will have upcoming system maintenance and replacement that will be funded by the operating fund. The tax bill on an average homestead will be \$1,522. Hearing no public comments, the Board closed the public hearing for the proposed 2024 tax rate at 7:12 p.m.
- 3. After discussion, upon motion by Director McCorkle, seconded by Director Campbell, the Board approved the attached Order adopting a total 2025 District tax rate of \$0.57 composed of an \$0.070 debt service tax and a \$0.50 operations and maintenance tax.
- 4. The Board reviewed the updates to the Amendment to Statement of Directors to the Board. After brief review and discussion, upon motion by Director McCorkle, seconded by Director Robicheaux, the Board adopted the updated Amendment of Statement of Directors.
- 5. It was noted that the District's financial advisor discussed the proposed term of a contract amendment with the Board of Directors at the October meeting. The amendment will permit an hourly rate payment structure for tax rate analysis and other issues requiring the input of the financial advisor. Typically, the financial advisor performs these functions in anticipation of payment from the sale of bonds; however, the District's mature status

makes it unlikely that there will be future bond sales. After brief review and discussion, upon motion by Director Campbell, seconded by Director McCorkle, the Board adopted the Masterson Advisors, LLC contract amendment.

- 6. The review and discussion of the audit report for the fiscal year ended May 31, 2025, was tabled until the District's November meeting.
- 7. The review of the District's investment policy was tabled until the District's November meeting.
- 8. The review for the compliance with Senate Bill 253 was tabled until the District's November meeting.
- 9. The Board then recognized Mr. Douglas McNiel who advised the Board regarding the District's continuing disclosure compliance filings. After the audit report for the fiscal year ended May 31, 2025 is complete, it will need to be publicly filed so existing bondholders can be sure that the District has the financial standing to meet its payment obligations. After brief discussion, upon motion by Director McCorkle, seconded by Director Robicheaux, the Board unanimously authorized the District's attorney's office to file as necessary.
- 10. The Board considered the minutes of the meeting of September 9, 2025. Upon motion by Director McCorkle, seconded by Director Campbell, the Board unanimously approved the minutes as presented.
- 11. Ms. Michelle Guerrero presented the tax assessor-collector's report reflecting the District's 2024 taxes are 97.929% collected. Ms. Guerrero presented three checks for the Board's review and approval and one wire transfer was made. After discussion, upon motion by Director McCorkle, seconded by Director Campbell, the Board voted unanimously to approve the tax assessor-collector's report.
- 12. The Board reviewed the delinquent tax report prepared by Perdue, Brandon, Fielder, Collings & Mott L.L.P. After reviewing the report, Ms. Guerrero requested the Board's approval to have the delinquent tax attorney move forward with door tagging and eventual termination on three delinquent properties. Director Maniscalco will work with the delinquent tax attorney to provide an updated contact address for one of the recipients of the door tags. After discussion, upon motion by Director McCorkle, seconded by Director Campbell, the Board approved the water termination letters.
- 13. Mr. Scott Shelnutt presented the operator's report which reflected 418 total connections in the District. Collections for the month were at \$40,943.05 with current billings at \$41,030.99. The report showed water accountability at 84.85% during this period. Total water plant pumpage for the prior month was 5,865,000 gallons. There were no permit violations reported at the wastewater treatment plant. The operator did not recommend placing any delinquent accounts onto the District's list of uncollectible accounts. The operator requested that the November agenda contain a discussion of the operator's contract. The operator informed the Board of an upcoming service line replacement that will impact the District's commercial properties, including the La Hacienda Restaurant. The operator will coordinate with the commercial properties to arrange an optimal time to cut off the water service and make the line

replacement. The operator informed the Board that the District passed its Texas Commission on Environmental Quality inspection with "no deficiencies."

Lastly, the Board and the operator discussed providing a payment plan to a commercial property that is delinquent in its water and sewage bills. It was noted that the property is a restaurant and will lose all ability to pay the delinquent bills and future bills if the water service is shut off. Upon motion by Director McCorkle, seconded by Director Robicheaux, the Board authorized the operator to work with the property on a payment plan to pay the bills and avoid the termination of water service. After discussion, upon motion by Director Robicheaux, seconded by Director McCorkle, the Board voted unanimously to approve the operator's report as presented.

- 14. Mr. Chris Burke presented the engineer's report. Mr. Burke provided updates on ongoing District projects, including the sanitary sewer rehabilitation project. Mr. Buke then discussed the District's conversion to surface water. The North Harris County Regional Water Authority is having trouble procuring all the required easements, so the installation of surface water lines has been pushed to at least the second quarter of 2026 and the water plant conversion has been pushed to at least the first quarter of 2026. The engineer also informed the Board that the wastewater treatment plant blower motor replacement has been completed, and the invoice has been provided to the District's insurance. After further discussion, upon motion by Director McCorkle, seconded by Director Campbell, the Board voted unanimously to approve the engineer's report as presented.
- 15. Mr. Douglas McNiel gave a brief attorney's report. He informed the Board that the District received a notice of consumer price index (CPI) increase from the solid waste provider GFL. The CPI increase is 6.53%. Following the December implementation of the \$1.67 increase, the new total per connection will be \$27.16. The District does not need to amend the rate order because of the "prevailing garbage rate" language.
- 16. The Board then reviewed the bookkeeper's report which reflected the District's operating fund contained \$2,556,360.79, the construction fund contained \$114,749.66, and the bond fund contained \$61,772.88. The Board discussed the high AT&T bill, and it was noted that this is for the District's water plant. The operator will look into changing service providers to lower the bill. Upon motion by Director McCorkle, seconded by Director Robicheaux, the Board voted unanimously to approve the bookkeeper's report.
 - 17. There was no executive session held.
 - 18. No other matters were discussed.

There being no further business to come before the Board, the meeting was adjourned.
