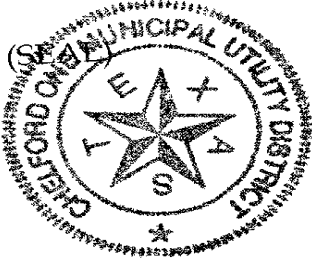


NOTICE OF MEETING
CHELFORD ONE MUNICIPAL UTILITY DISTRICT

The Board of Directors of Chelford One Municipal Utility District of Harris County, Texas, will hold a regular meeting on **Monday, November 17, 2025, at 11:30 a.m.**, at Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, **on the First Floor, Executive Conference Room**, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. District security matters, including report from On-Site Protection LLC.
4. Tax Assessor/Collector report, including payment of the bills on the tax account, delinquent tax collections, approval of Depository Pledge Agreements, and requests for estimates of taxable value.
5. Operation of District facilities, including:
 - a. billings, repairs and maintenance;
 - b. landscape maintenance of well site tract and adjacent tracts; and
 - c. amend Rate Order, if appropriate.
6. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
7. Approve services agreement with engineer.
8. Engineering matters, including:
 - a. authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate;
 - b. deeds, easements, consents to encroachment, requests for service, utility commitment letters, and GIS;
 - c. District interconnect matters, including interconnect termination agreements and related conflict waivers; and
 - d. approve Letter Agreement.
9. Discuss rate increase for engineering services and take appropriate action.
10. Mission Bend Integrated Water System matters.
11. Chelford City Regional Wastewater Treatment Plant matters.
12. West Harris County Regional Water Authority matters.
13. Report on the Greater Mission Bend Area Council.
14. Mission Bend Greenbelt Association matters.
15. Financial and bookkeeping matters, including: approval of Depository Pledge Agreements, payment of bills, and opening of bank accounts, if appropriate.

16. Adopt Resolution Casting Ballot for the Election of a Person to the Board of Directors of the Harris Central Appraisal District.
17. Historical bond and tax report to Comptroller.
18. Communication and website matters, including consideration of proposals and authorize appropriate action.
19. Meeting schedule.
