The district is located wholly or partly in the extraterritorial jurisdiction of the City of Houston. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved. The district has entered into a strategic partnership agreement with the City of Houston. This agreement may address the timeframe, process, and procedures for the municipal annexation of the area of the district located in the municipality's extraterritorial jurisdiction. The purpose of the district is to provide water, sewer, drainage, flood control, fire-fighting, road, parks and recreational, or other types of facilities and services. The cost of district facilities is not included in the purchase price of your property.
