The only modification and update to the Notice is in regard to Item 3, which now should read as follows:

- 3. The most recent rate of District taxes on property located in the District is \$0.285 per \$100 assessed valuation.

NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in Fall Creek Management District (the "District") and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds.

The current rate of the District property is \$0.285 on each \$100 of assessed valuation. The total amount of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters and excluding any bonds or any portion of bonds issued that are payable solely from the revenues received or expected to be received under a contract with a governmental entity, approved by the voters are:

- (i) \$30,000,000 for road facilities; and
- (ii) \$50,000,000 for economic development facilities, services and programs.

The aggregate initial principal amounts of all such bonds issued are:

(i) \$6,970,000 for road facilities; and

(ii) \$0.00 for economic development facilities, services and programs.

The District is located wholly or partly in the extraterritorial jurisdiction of the City of Houston. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved.

The purpose of the District is to provide for construction, maintenance and operation of improvements necessary or convenient to provide roads; promoting economic development and diversification; developing and expanding transportation and commerce; promoting health, safety, and welfare; enhancing the economy and vitality of the area as a community and business center; improving traffic control, bettering safety for pedestrians, and enhancing scenic and aesthetic beauty and economic development to lands within the boundaries of the District. The cost of District facilities is not included in the purchase price of your property.
