
We, the undersigned, constituting a majority of the members of the Board of Directors of GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT NO. 68 (the "District"), do hereby make, execute and affirm this Amendment to Information Form in compliance with TEXAS WATER CODE §49.452 and §49.455 and 30 TEXAS ADMIN. CODE §293.92. We do hereby certify as follows:

1. The most recent rate of taxes levied by the District on property within the District is \$0.864 per \$100 of assessed valuation.

2. The aggregate initial principal amounts of all bonds issued for one or more of the specified facilities of the District payable in whole or in part from property taxes (excluding refunding bonds and any bonds or portion of bonds payable solely from revenues received or expected to be received pursuant to a contract with a governmental entity) that have been previously issued is \$28,525,000.

3. The form Notice to Purchasers required by § 49.452, Texas Water Code, as amended, to be furnished by a seller to a purchaser of real property in the District is attached hereto as Exhibit "A" and incorporated herein for all purposes.





EXHIBIT "A"

NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in the Galveston County Municipal Utility District No. 68 (the "District") and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$0.8640 on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by the voters are:

\$50,000,000 for water, sewer, and drainage facilities; and
\$32,500,000 for refunding bonds.

The aggregate initial principal amounts of all such bonds issued are:

\$28,525,000 for water, sewer, and drainage facilities; and
\$80,000 for refunding bonds.

The District is located wholly or partly within the corporate boundaries of the City of LaMarque, Texas and the City of Hitchcock, Texas. The municipality and the District overlap, but may not provide duplicate services or improvements. Property located in the municipality and the District is subject to taxation by the municipality and the District.

The purpose of the District is to provide water, sewer, drainage, and flood control facilities and services. The cost of District facilities is not included in the purchase price of your property.
