3. 2026 Directors Election, including:
  - a. adopt Resolution Designating an Agent of the Secretary of the Board of Directors During the 2026 Board of Directors Election Period;
  - b. authorize Notice of Deadline to File Applications for Place on the Ballot; and
  - c. approve contracting for election services and any associated agreements if necessary with Fort Bend County.
4. Approve Audit for the District and regional sewage treatment plant for fiscal year ended September 30, 2025.
5. Garbage collection and recycling matters.
6. Security and patrol matters, including financial contributions for security services from District Homeowners Associations, discuss security upgrades and recommendations, and authorize appropriate action.
7. Update on LPR camera systems installation.
8. Report on mowing and detention pond maintenance and authorization of work orders and proposals, as appropriate, and graffiti removal matters.
9. Financial and bookkeeping matters, payment of the bills, and review of investments.
10. Accept annual disclosure statements for Investment Officer and bookkeeper.
11. Annual Report regarding Post-Issuance Compliance Policy.
12. Tax assessment and collections matters, including delinquent tax collections, installment agreements, payment of tax bills, and delinquent tax report.
13. Operation of District facilities, including:
  - a. billings, repairs and maintenance;
  - b. annual review of customer deposit refunds;
  - c. review and update 5-year Capital Improvements Repair and Maintenance Plan;
  - d. hearing on termination of water and sewer service to delinquent customers, authorize termination of service;
  - e. amendment of Rate Order, if applicable; and


