3. 2026 Directors Election, including:
 - a. adopt Resolution Designating an Agent of the Secretary of the Board of Directors During the 2026 Board of Directors Election Period;
 - b. authorize Notice of Deadline to File Applications for Place on the Ballot;
 - c. approve contract for election services and any associated agreements if necessary with Brazoria County;
 - d. adopt Order Calling Directors Election; and
 - e. authorize Notice of Election.
4. Financial and bookkeeping matters, including:
 - a. payment of the bills and review of investments;
 - b. accept annual disclosure statements for bookkeeper and Investment Officer;
 - c. adopt Resolution Establishing the Authorized Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions; and
 - d. conduct annual review of Investment Policy and adopt Resolution Regarding Annual Review of Investment Policy.
5. Financial and bookkeeping matters, including payment of the bills and review of investments.
6. Tax assessment and collection matters.
7. Engineer's report, including:
 - a. design, plan approval, advertisement for bids, contract award, approval of pay estimates and change orders, materials and field testing, permitting, final acceptance, and other necessary actions; and
 - b. deeds, easements, plats and consents to encroachment, requests for service or utility commitment letters.


8. Operating matters, including hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
