NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors ("Board") of the above captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Tuesday, January 27, 2026 at 12:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

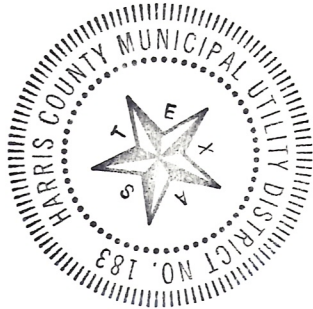
1. Public comments;
2. Review and approve the minutes of the Board of Directors meetings held on December 5, 2025, and December 18, 2025;
3. Bookkeeper's Report, including financial and investment reports, discussion regarding status of investment of District funds, authorizing the payment of invoices presented, and authorizing any other actions necessary or appropriate in connection therewith;
4. Authorize preparation and submission of District information to Texas Comptroller of Public Accounts as required by Section 403.0241, Texas Government Code, and Chapter 203, Texas Local Government Code, for inclusion in the Special Purpose District Public Information Database;
5. Consider approving amended and restated agreement with Municipal Information Services, LLC; authorize any action necessary in connection therewith; and authorize acceptance of Texas Ethics Commission ("TEC") Form 1295 in connection therewith;
6. Tax Assessor-Collector's Report, including status of delinquent tax accounts, and authorizing payment of invoices presented and moving of accounts to uncollectible roll;
7. Grant exemptions from taxation for 2026, and the adoption of a Resolution in connection therewith;
8. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Personal Property Taxes and authorize delinquent tax attorney to collect delinquent personal property taxes beginning April 1, 2026, including the filing of lawsuits, as necessary;

9. Annual review of list of commercial businesses within the District that collect sales tax pursuant to the terms of a Strategic Partnership Agreement between the District and the City of Houston;
10. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment payment agreements, the filing of proofs of claim, and termination of water service, if appropriate;
11. Operations and Maintenance Report, including:
 - a) Repair and maintenance of facilities, including the repairs identified in Quiddity Engineering's Annual Water Plant Inspection;
 - b) Written appeals of District charges;
 - c) Referral of accounts for collection and approve write-off of uncollectible accounts;
 - d) Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
 - e) Discussion regarding emergency interconnect(s);
 - f) Status of line breaks caused by Ezeefiber and collection of repair costs for same;
 - g) Discussion regarding rental meters issued by the District and water trucks taking District water, and take any action necessary or appropriate in connection therewith; and
 - h) Discussion regarding security improvements at District facilities and take any action necessary or appropriate in connection therewith;
12. Issuance of utility commitments, and authorize acceptance of TEC Form 1295, in connection therewith, including discussion regarding customer violation, plan approval for Distinction International Christian Church, and amendment to utility commitment;
13. Discussion regarding proposed administrative building, including discussion regarding special meeting to discuss bids;
14. Security Report, including: (i) report from Harris County Sheriff's Office; (ii) discussion regarding patrol services; (iii) discussion regarding monitoring services; and (iv) discussion regarding facility security, and take any action necessary or appropriate in connection therewith;
15. Discussion of renewal of District insurance coverages and authorize solicitation of proposals for same;
16. Discussion regarding West Harris County Regional Water Authority related issues, including: (i) 2026 Director appointment process, and the adoption of a Resolution in connection therewith; and (ii) completion of 2025 water usage reporting forms;

17. Matters related to the Directors Election to be called for May 2, 2026, including memorandum regarding independent elections, and (ii) discussion regarding accessible voting systems, and take any action necessary or appropriate in connection therewith;

19. Engineer's Report, including:
 - a) Authorizing design for the construction of facilities within the District and approval of related storm water plans;
 - b) Authorizing the advertisement for bids for the construction of facilities within the District, including:
 - (i) Windsong Waterline Rehabilitation – Phase I;
 - c) Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities to serve land within the District, approval of any related storm water permits, and authorize acceptance of TEC Form 1295 in connection therewith;
 - d) Status of construction of facilities to serve land within the District, and approval of any change orders, and authorize acceptance of TEC Form 1295 in connection therewith, including:
 - (i) Generator Addition at Remote Water Well No. 2 (McDonald Municipal and Industrial); and
 - (ii) Sanitary Sewer Rehabilitation - Phase III (Allteams Solutions, LLC);
 - e) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes;


