


## NOTICE OF MEETING

### CHELFORD ONE MUNICIPAL UTILITY DISTRICT

The Board of Directors of Chelford One Municipal Utility District will hold a regular meeting on Monday, February 16, 2026, at 11:30 a.m., at Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, on the First Floor, in the Executive Conference Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. District security matters, including report from On-Site Protection LLC.
4. Tax assessor/collector report, including payment of the bills on the tax account, delinquent tax collections, approval of Depository Pledge Agreements, and requests for estimates of taxable value.
5. Adopt Resolution Concerning Exemptions from Taxation.
6. Adopt Resolution Regarding Development Status for 2026 Tax Year.
7. Operation of District facilities, including:
  - a. billings, repairs and maintenance;

  - b. deeds, easements, consents to encroachment, requests for service, and utility commitment letters;
  - c. District interconnect matters, including interconnect termination agreements and related conflict waivers; and
  - d. approve Letter Agreement.

11. Chelford City Regional Wastewater Treatment Plant matters.
12. West Harris County Regional Water Authority matters.
13. Report on the Greater Mission Bend Area Council.
14. Mission Bend Greenbelt Association matters.
15. Financial and bookkeeping matters, including:
  - a. approval of Depository Pledge Agreements, payment of bills, and opening of bank accounts, if appropriate;

- b. Chelford City Regional Wastewater Facility financial matters;
  - c. Mission Bend Greenbelt Authority financial matters; and
  - d. discuss Association of Water Board Directors winter conference, approve reimbursement of eligible expenses, and authorize attendance at summer conference.
