The Board of Directors of Grand Oaks Municipal Utility District of Montgomery County, Texas will hold a regular meeting on Monday, March 30, 2026, at 12:00 p.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Concho Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Receive public comments.
2. Approve minutes of prior meetings.
3. Garbage service matters.
4. Financial and bookkeeping matters, including:
 - a. payment of bills and review of investments; and
 - b. authorize renewal of electricity contract.
5. Tax assessment and collection matters, including delinquent tax collections, installment agreements, payment of tax bills, and requests for estimates of taxable value.
6. Operation of District facilities, including:
 - a. billings, repairs, and maintenance;
 - b. approve and authorize operator to file water loss audit; and
 - c. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
7. Conduct annual review of Drought Contingency Plan.
8. Review Critical Load Spreadsheet for District's facilities and authorize annual filing.
9. Drainage and detention facility maintenance matters, including repairs to District drainage facilities and proposals for work.
10. Engineering matters, including:
 - a. approve pay estimates and change orders, including:
 - i. Glen Oaks, Section 6, water, sanitary sewer, and drainage;
 - b. deeds, easements, execution of plats, consents to encroachment, conveyances, and requests for service or utility commitment letters;
 - c. review Emergency Preparedness Plan and authorize filing of updates, if necessary; and
 - d. update on preparation of bond application no. 5 and adopt Resolution Authorizing Application to the Texas Commission on Environmental Quality for Approval of Project and Bonds.
11. 2026 Directors Election, including:
 - a. accept Certificate Declaring Unopposed Status of Candidates for Election to the Board of Directors;
