


NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 365

The Board of Directors of Harris County Municipal Utility District No. 365 will hold a special meeting on **Wednesday, April 29, 2026, at 6:00 p.m.**, at the Coles Crossing Community Center, 13050 Barker Cypress Road, Cypress, Texas 77429*, to discuss and, if appropriate, act upon the following items:

1. Public comment.**
2. Joint facilities matters with Harris County Municipal Utility District No. 364 ("MUD 364"), including:
 - a. sanitary sewer evaluation and rehabilitation project;
 - b. maintenance and repair of shared outfall pipes and drainage channels;
 - c. update on request to Harris County for funding assistance for drainage/detention projects;
 - d. maintenance and repair of fences at joint facilities; and
 - e. resident reimbursement request relating to operation of joint facilities.
3. Parks and recreational amenities matters, including:
 - a. update on MUD 364 Walking Trail Improvements Projects; and
 - b. review matters relating to Walking Trail/Park sign project.
4. Coles Crossing Stormwater Detention and Water Quality Improvement Project, including associated costs, federal grant, timeline for implementation, and related matters, including:
 - a. Interlocal Agreement with Harris County for Stormwater Detention Basin in Coles Crossing.
5. San Jacinto Regional Flood Planning Group flood mitigation evaluation for Coles Crossing detention pond, and take appropriate action.
6. Community events.
7. Discuss schedule for future joint meetings.

Harris County Municipal Utility District No. 365 reserves the right to adjourn into executive session at any time during the course of this meeting to discuss any of the matters listed above, as authorized by the Texas Open Meetings Act, Texas Government Code §§ 551.071 (Consultation with Attorney), 551.072 (Deliberations about Real Property), 551.073 (Deliberations about Gifts and Donations), 551.074 (Personnel Matters), 551.076 (Deliberation about Security Devices), and any other provision under Texas law that permits a governmental body to discuss a matter in a closed executive session.
