NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular meeting at **1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas**, said address being a meeting place of the District.

The meeting will be held on Friday, May 15, 2026, at 12:00 Noon.

The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to such matters:

1. Public Comments;
2. Review and approve minutes of the April 17, 2026, Board of Directors meeting;
3. Acceptance of Qualification Statements, Bonds, Oaths of Office, Affidavits of Current Director, and Elections Not to Disclose Certain Information for Directors Knickerbocker, Cox, and Grzanka;
4. Election of officers of Board of Directors;
5. Approval of District Registration Form relative to election of Directors;
6. Authorize preparation and maintenance of a local government officers list in connection with conflict of interest disclosure requirements;
7. Discuss changes to cybersecurity and artificial intelligence training requirements applicable to Directors of the district;
8. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented, approving tax refunds, and approving moving of accounts to the uncollectible roll, as needed;
9. Report and legal action taken by the District's Delinquent Tax Collections Attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
10. Bookkeeper's Report, including financial investment reports and authorizing the payment of invoices presented;

 - (iii) Status of construction of facilities to serve land within the District, including the approval of any pay estimates and change orders, and authorize acceptance of TEC Form 1295, as applicable in connection therewith, including:
 - (a) Cleaning and televising of sanitary and storm sewer systems;
 - (iv) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, acceptance of facilities for operation and maintenance purposes, and authorize acceptance of TEC Form 1295, as applicable in connection therewith;
 - (v) Status of Joint Water Plant No. 1 Rehabilitation Project by Harris County Municipal Utility District No. 276 ("HC MUD No. 276");
 - (vi) Status of installation of generator at Joint Water Plant No. 2 by HC MUD No. 276;
 - (vii) Status of Wastewater Treatment Plant Rehabilitation Project by Northwest Harris County Municipal Utility District No. 16;
 - (viii) Status of potential improvement of tract of land adjacent to Wastewater Treatment Plant and acquisition of easement(s) necessary therefor; consider engagement of landscape architect related to same;
 - (ix) Status of proposed replat of Kingfield Section 2 and acquisition of easement(s) in connection therewith; and
 - (x) Status of investigation of cracking in concrete basins at Wastewater Treatment Plant;
