4. Reorganize Board and authorize execution of District Registration Form.

7. Financial and bookkeeping matters, including payment of the bills, review of investments, and depository pledge agreements.

 - a. water plant no. 1 canopy installation for chemical tanks;
 - b. water well no. 3;
 - c. next phase of District facilities;
 - d. capital improvement plan;

 - f. deeds, easements, consents to encroachment, access agreements, pipeline crossing reimbursement and encroachment agreements, requests for service, utility commitment letters, and appraisals.

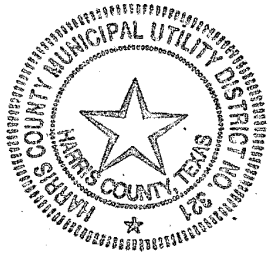
