  - c. amend Rate Order; and
  - d. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
8. Drainage and detention facility maintenance matters, including repairs to District drainage facilities and proposals for work.
9. Report on development in the District.
10. Maintenance Agreement with Grand Oaks Homeowners Association and take appropriate action.
11. Engineering matters, including:
  - a. approve pay estimates and change orders;
  - b. deeds, easements, execution of plats, consents to encroachment, conveyances, and requests for service or utility commitment letters;
  - c. adopt Resolution Expressing Intent to Reimburse; and
  - d. update on bond application no. 5.
12. 2026 Directors Election, including:
  - a. approve and distribute Certificates of Election; and
  - b. approve Directors' Sworn Statements, Bonds, and Oaths of Office.
