3. Hear reports regarding the management of the community center, swimming pool administration, golf course, mowing and security and take any necessary action;
4. Hear operator's report, discuss district operations and any appeals, receive input from operator concerning same and take any necessary action; Discuss Daily Monitoring Report requirements and take any necessary action;
5. Consider amendment to Rate Order and take any necessary action;
6. Hear engineer's report, consider approval of any change orders, authorize any advertisements for bids or the award of any contracts; consider any capacity requests and take any necessary action;

7. Hear tax assessor-collector's report and take any necessary action;
8. Consider adopting Resolution Concerning District Development Status for 2026 Tax Year and take any necessary action;
9. Hear treasurer's report and take any necessary action;
10. Consider approving Order Calling Directors Election and Notice of Election, approving entering into an agreement with Harris County for election services and take any necessary action;

考虑审批董事选举令和选举公告，就选举服务审批是否与哈里斯郡签订协议，并采取任何必需措施；

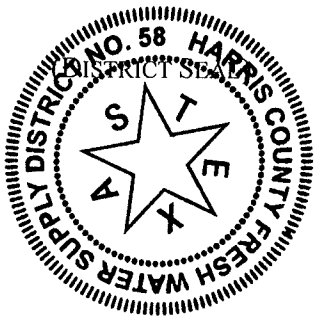
