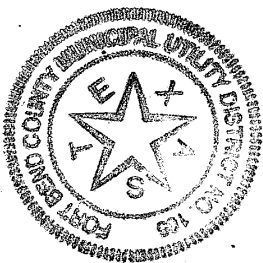

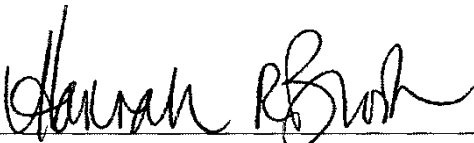
The Board of Directors of Fort Bend County Municipal Utility District No. 165 will hold a regular meeting on Thursday, September 10, 2026, at 9:00 a.m., at the offices of Municipal District Services, LLC, 406 W. Grand Parkway S., Suite 260, Katy, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Security matters, including renewal of Interlocal for Law Enforcement Services with Fort Bend County.
4. Fire protection matters, including Fire Protection Agreement with the City of Richmond, and authorize appropriate action.
5. Garbage and recycling collection matters.
6. Financial and bookkeeping matters, including payment of bills and review of investments and approval of direct deposit payment systems and related agreements
7. Conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form.
8. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
9. Report from Storm Water Solutions on maintenance of facilities.
10. Operation of District facilities, including:
 - a. billings, repairs and maintenance, customer appeals, back charges, and message language on water bills; and

 - i. Sections 5, 6, and 8 street repairs and acceptance;
 - ii. Lift Station No. 1 Improvements; and
 - iii. Pedestrian Crossing at Marble Ravine and Gibraltar Place;
 - b. Grand Mission Regional Projects, including:
